Our work in the community and our efforts to enhance the quality of life on the Westbank continue to be a driving force for WBIA. It is critical that we work together to find solutions and effect change to attract employers and residents, and to maintain a thriving local economy. Change can take time. WBIA Committees work with the Coalition for Sustainable Flood Insurance (CSFI)/RISK rating 2.0, Mechatronics cohort graduation, Women in Skilled Trades, Litter abatement, Jefferson Ready Start Network, and the JP Industrial Zoning study—that's just a few areas of interest that come to mind. Our members participate in discussions to advocate on your behalf as decisions are made about our community.

WBIA Luncheons promote communication of local and regional issues. Hopefully, you were able to attend our lunch meetings with Dr. James Gray on education, Jerry Bologna with an economic outlook or the informative look at Risk Rating 2.0 from our Gulf Coast Coalition field experts.

We've had some fun too. I was asked to speak on behalf of our Association at the re-opening of Avondale, along with the Governor, Congressman Carter and Parish President Sheng. This waterfront industrial park, "Avondale Global Gateway" is the leader for the Westbank's economic future and will certainly be a leader for the entire state. I was honored to represent the WBIA as a part of the celebration and gain some high-profile attention for the group. 2022 moved us back outside where we noticed the overwhelming amount of litter and homelessness. We have heard your concerns, and we are meeting with local and state officials about possible solutions.

Workforce issues are being tackled from a number of sides. We are working with a Think Tank at Delgado for Industry; regionally working with Women in Skilled Trades, and locally with Career Technical Education programs and early childhood education; we will find some solutions.

Infrastructure takes more patience than any other committee. Peters Road is back on agendas; JP Permits procedures are being reviewed; and the JP Industrial Zoning Study has created a couple of focus groups and conducted various discussions with zoning and council members.

The more we hear from you, our WBIA members, the more we can include your voice at the table. Use your membership by communicating your concerns and your successes.

The consultants left the I-LF (Landfill) and AIM (Avondale) relatively untouched. There were no issues or concerns submitted to the consultants related to the landfill.

Property buffers and landscaping has been modified for most districts.

All districts, except HM-O, are allowed variances. HM-O has additional regulations imposed.

JEFFERSON PARISH - INDUSTRIAL ZONING STUDY

The parish held two public meetings that same week the draft was released: one on the Eastbank and one on the Westbank. You can view the full draft <u>online here.</u> The webpage is open to public comments. Feel free to submit any concerns or suggestions directly to WBIA Infrastructure Committee or to a WBIA Board member.

WBIA is working with industry partners and landowners as we monitor the study and meeting with councilmembers about member concerns. Contact admin@wbianola.com or 504-367-1721.

The first draft was released in November. The New proposed districts are:

I-MU, Industrial Mixed Use, Incorporates former OW-1

I-L, Light Industrial (formerly M-1)

I-H, Heavy Industrial (formerly M-3)

I-LF, Landfill Industrial (formerly M-4)

Overlay Industrial Zoning Districts include: HM-O, Hazardous Materials Overlay and

AIM, Avondale Industrial Marine Overlay

The parish hired Camiros, a planning and zoning consulting firm, to study the current industrial zoning throughout Jefferson. According to the framework report (you can view online at: https://jpindustrialzoning.com/), a primary goal of this effort is to create a set of industrial districts that build more predictability into the zoning process.

Jefferson Parish GREEN INFRASTRUCTURE Plan is part of Jefferson Parish's continuing efforts to manage rainwater as a more resilient community. The Parish objective is to create a plan that will provide guidance to the Council and Administration on best practices for integrated stormwater management and green infrastructure on public and private property.

TRAINS ARE MAKING A COME BACK INFRASTRUCTURE in Louisiana and Gulf Coast

With trains being a part of the infrastructure projects; have you thought of ways to get on board as the projects move through the city? WBIA stays connected with regional partners at GNO, Inc.

In preparation for the return of **New Orleans-Mobile Passenger Rail**, the Southern Rail Commission and Amtrak jointly filed a Consolidated Rail Infrastructure and Safety Improvements (CRISI) grant application, with support of CSX, Norfolk Southern, and the Alabama Port Authority, for the <u>Gulf Coast Corridor Improvement Project</u>. The project would leverage \$44.6M in non-federal match to make \$223M in improvements, adding sidings and crossings to reduce trip time. Meanwhile, DOT's Federal Railroad Administration has opened applications for <u>Federal-State Partnership for Intercity Passenger Rail Grant Program</u>, exclusively for projects outside of the Northeast Corridor, with applications due on March 7, 2023.

DOT has announced the opening of FY23 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant Program, with applications due on February 28, 2023. A DOT webinar series, with guidance on the RAISE application process and benefit-cost analysis, will begin on January 5. The FY22 RAISE cycle awarded Baton Rouge and Gonzales \$20M to design and construct their passenger rail terminals, to accommodate New Orleans-Baton Rouge service.
